BILL NO. 1320

ORDINANCE NO. 1144

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY ADDING THE CHAIRMAN OF THE BOARD OF COMMISSIONERS TO THE SUCCESSION OF AUTHORITY FOR EMERGENCY MANAGEMENT DUTIES.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 65.350 of the Washoe County Code is hereby amended to read as follows:

65.350 Succession of authority. If the manager is unavailable or otherwise unable to perform his duties set forth in this chapter, the succession of authority shall be:

- 1. First, to the designated assistant county manager. If the designated assistant county manager is unavailable, to another assistant county manager.
- 2. Second, if no assistant county manager is available, to the director of public works.
- 3. Third, if the director of public works is unavailable, to the chairman of the board.

[Business Impact Note: The Board of County Commissioners hereby finds that this ordinance does not impose a direct and significant economic burden upon a business, nor does it directly restrict the formation, operation or expansion of a business.]
