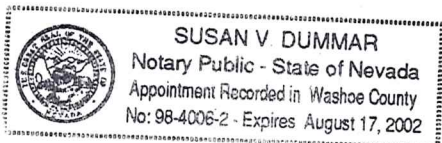

ORDINANCE NO. 1146

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REPEALING SEC. 70.38653 RELATING TO BEING UNDER THE INFLUENCE OF ALCOHOL IN A VEHICLE AND AMENDING SEC. 70.38652 TO CONFORM WITH STATE LAW.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 70.38653 of the Washoe County Code is hereby repealed.

SECTION 2. Section 70.38652 of the Washoe County Code is hereby amended to read:

70.38652 Drinking while driving. It is unlawful for any person to drink any intoxicating liquor in a motor vehicle which such person is driving or in actual physical control of such motor vehicle upon a road or highway within the county.

[Business Impact Note: The Board of County Commissioners hereby finds that this ordinance does not impose a direct and significant economic burden upon a business, nor does it directly restrict the formation, operation or expansion of a business.]
