SUMMARY: An ordinance amending Washoe County Code by adding the Wadsworth area and Stampmill Estates Subdivision to the definition of congested area for purposes of control of dogs.

ORDINANCE NO. 1169

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY ADDING THE WADSWORTH AREA AND STAMPMILL ESTATES SUBDIVISION TO THE DEFINITION OF CONGESTED AREA FOR PURPOSES OF CONTROL OF DOGS, AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 55 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

55.090 Wadsworth and Stampmill Estates Subdivision: Congested area. The following described area within the unincorporated area of the county is determined to be a congested area: All that certain area within the following described parcels of land within the unincorporated area of Washoe County: The NW ¼ of section 3, the NE ¼ of section 4, the NW ¼ of section 8 and all that portion of the SW ¼ of section 8 lying northwesterly of the I-80 right-of-way, all in T. 20 N., R. 24 E., M.D.B.&M.
