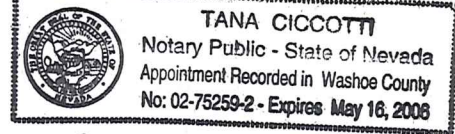

SUMMARY: An ordinance amending the Washoe County Code by adding provisions to provide additional funding for the county coroner for certain purposes through an increase in the fee paid for a death certificate copy.

ORDINANCE NO. 1284

AN ORDINANCE AMENDING WASHOE COUNTY CODE CHAPTER 35 BY ADDING THERETO PROVISIONS CREATING AN ACCOUNT FOR THE SUPPORT OF THE COUNTY CORONER FUNDED BY AN INCREASE OF \$1.00 IN THE FEE CHARGED FOR A CERTIFIED COPY OF A DEATH CERTIFICATE WITH SUCH FUNDS TO BE USED SOLELY BY THE CORONER FOR CERTAIN PURPOSES, AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 35.120 of the Washoe County Code is hereby amended by adding thereto two new subsections 4 and 5 as follows:

35.120 County Coroner; office created; qualifications and appointment; facilities; and special account and money.

1. The office of coroner is hereby created.
2. The board shall establish qualifications for appointment to the office of coroner and shall appoint a suitable and qualified person to serve as coroner at the board's pleasure.
3. Office space and necessary facilities for the coroner shall be provided for by the board. All costs, salaries and expenses connected with or entailed in the operation of the coroner's office shall be borne and provided for by the county.
4. A segregated account in the general fund for the support of the office of the county coroner is created pursuant to NRS Chapter 259, and is regulated as follows:
 - (a) The money in it must be accounted for separately and not as a part of any other account;
 - (b) Any interest and income earned upon the money in this account must be credited to this account;
 - (c) Any money remaining in this account at the end of any fiscal year shall not revert to the county general fund and shall be carried forward in this account to the next fiscal year;
 - (d) Claims against this account must be paid as other claims against the county are paid;
 - (e) Money in this account must be used by the coroner to pay expenses relating to:
 - (1) Training for a member of the staff of the office of the county coroner;
 - (2) Training an ex officio coroner and his deputies on the investigation of deaths; and
 - (3) The purchase of specialized equipment for the office of the county coroner.

5. The county treasurer shall deposit into this segregated account, described in subsection 4 above, the \$1.00 increase in the fee collected by the county district health officer and the State Registrar of Vital Statistics for furnishing a copy of a certificate of death originating in Washoe County, pursuant to NRS Chapters 440 and 259.
