ORDINANCE NO. 1369

AN ORDINANCE REORGANIZING THE EXISTING NRS CHAPTER 473 SIERRA FIRE PROTECTION DISTRICT INTO A FIRE PROTECTION DISTRICT CREATED AND GOVERNED BY NRS 474.460 TO 474.540, INCLUSIVE; DESCRIBING THE BOUNDARIES THEREOF AND THE TERRITORY INCLUDED THEREIN; AUTHORIZING CONTRACTS BETWEEN THE DISTRICT AND WASHOE COUNTY; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Organization, name of district.

Having received the State Forester Fire wardens written approval of the County's resolution to reorganize the Sierra Fire Protection District, pursuant to the authority contained in NRS 474.555, and in order to better provide for the prevention and extinguishment of fires, the existing NRS chapter 473 Sierra Fire Protection District is hereby re-organized in Washoe County, Nevada, as a fire protection district created and governed by NRS 474.460 to NRS 474.540, inclusive. The newly reorganized district shall continue to be known as the Sierra Fire Protection District, and its boundaries are described in Section 2 of this ordinance.

SECTION 2. Boundaries of district.

Except as otherwise provided in this ordinance, the boundaries of the Sierra Fire Protection District are described as follows:

TOWNSHIP 21 NORTH, RANGE 18 EAST

- That portion of Township 21 North, Range 18 East, Section 19 south and west of the US 395 right of way, excepting therefrom that portion outside Washoe County limits and the State of Nevada boundary.
- That portion of Township 21 North, Range 18 East, Sections 20 and 29 south and west of the US 395 right of way.
- Township 21 North, Range 18 East, Section 30 excepting therefrom that portion outside Washoe County and State of Nevada boundary.
- That portion of Township 21 North, Range 18 East, Section 34 south and west of the US 395 right of way, excepting therefrom that portion within City of Reno City limits

TOWNSHIP 20 NORTH, RANGE 18 EAST

- Township 20 North, Range 18 East, Sections, 6, 7, 18, 19, 30, and 31, excepting therefrom those portions outside the Washoe County and State of Nevada boundary to the west.
- Township 20 North, Range 18 East, Sections 5,6, 8, 35, and 36, excepting therefrom those portions within City of Reno limits.
- Township 20 North, Range 18 East, Sections 1, 2, and 3, excepting therefrom those portions north and east of the US 395 right of way.

TOWNSHIP 20 NORTH, RANGE 19 EAST

- Township 20 North, Range 19 East, Sections 18, 19, 20, 28, 29, 30, and 32 in their entirety.

- 2. Fire protection districts formed and existing in accordance with the provisions of: chapter 473 of NRS or NRS 474.010 to 474.450, inclusive, or other fire protection districts formed and existing in accordance with the provisions of NRS 474.460 to 474.540, inclusive.

SECTION 4. Contracts between county and district.

Pursuant to the provisions of NRS 474.475, the Board of County commissioners of Washoe County, Nevada, hereby authorizes the execution of contracts between Washoe County and the Sierra Fire Protection District for the prevention and control of fires and concerning the exercise of the powers provided in NRS 474.470.

SECTION 5. Effective Date.

This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.


