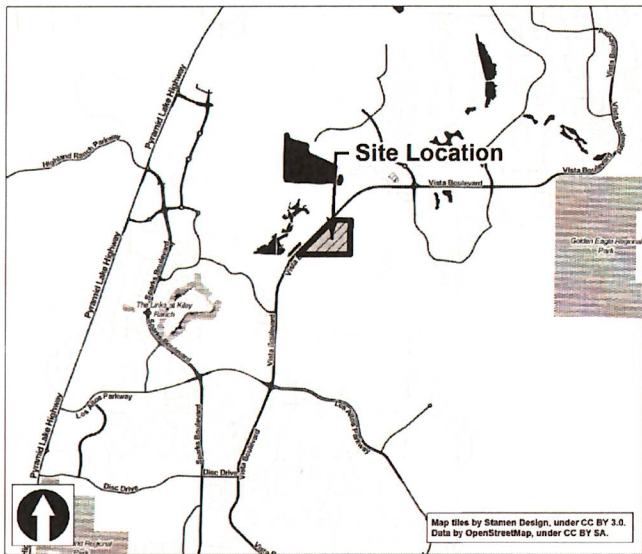

IMPROVEMENT PLANS FOR GOLDEN TRIANGLE MAIN ACCESS ROAD

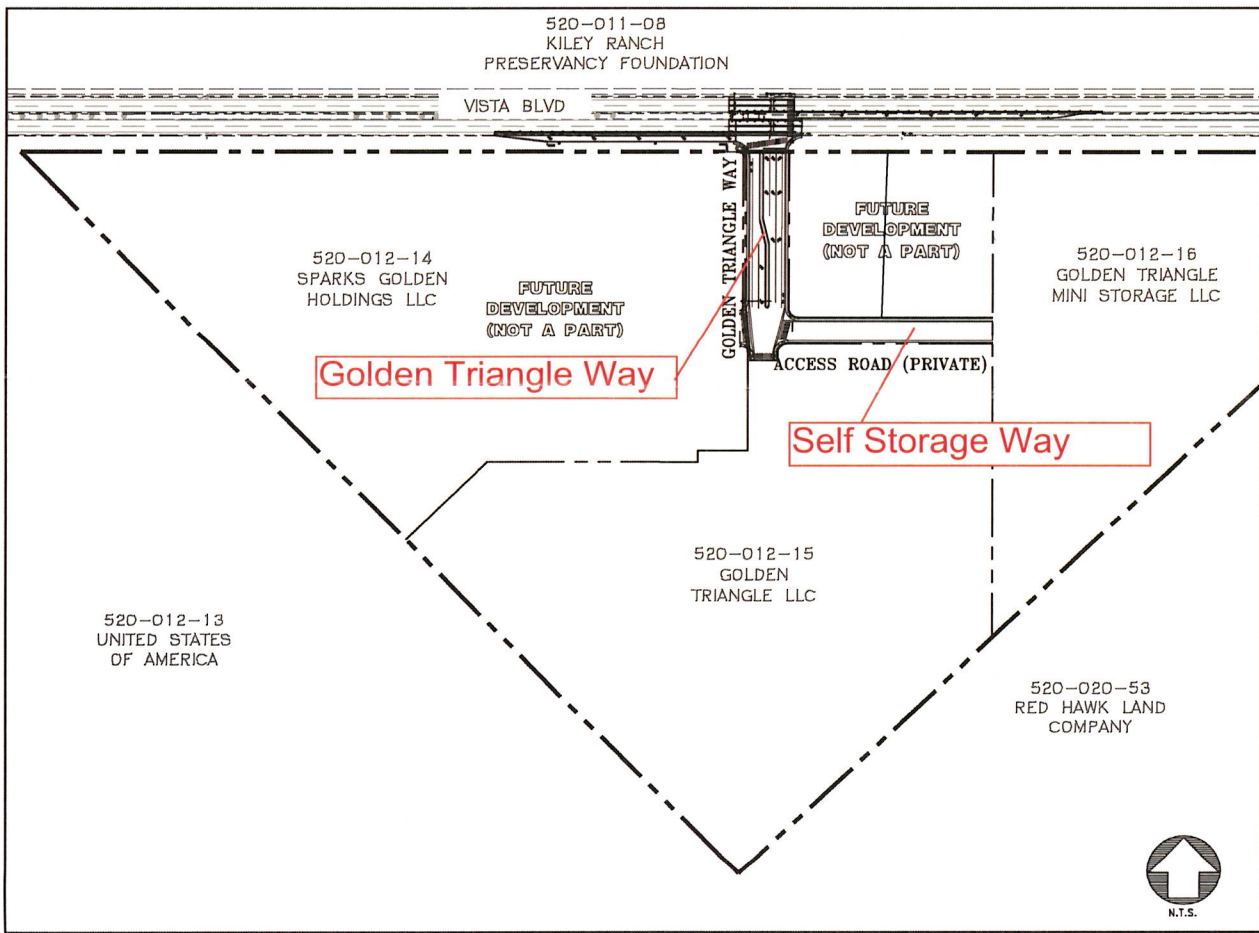
