#### **PROJECT HIGHLIGHTS**

# Arrowcreek Open Space Fuels Reduction Project

• Working with community partners to coordinate Arrowcreek HOA and Washoe County fuel reduction projects.

## Ballardini Ranch Trail connection to Thomas Creek

- Funded by 2000 WC-1 Bond and SNPLMA.
- Layout and design of connector from Ballardini Ranch to Thomas Creek is in draft review. Contractor is Donald Hays Trail Contractor, Inc.

## Galena Terrace Park

- Project in cooperation with Galena Terrace Homeowners Association to construct new playground facility that will be managed and maintained by HOA.
- Design Workshop with neighborhood has been completed. Approximately 40 people attended. LA Studio's (landscape design firm) has taken conceptual plans created by neighborhood members and will be designing two formal plans.
- Formal plans have been created and forwarded to GTMA for selection of preferred design.

## Land and Water Conservation Fund

 Washoe County applied for a grand for the resurfacing of the playground at the South Valley Regional Park. This would replace the existing wood chip surfacing with a rubberized material.

## New Washoe City Park Rehabilitation

- Project to remove old play structure and replace with a new play structure, seating areas, hardscape and appropriate fall protection below the play structure.
- Approved by the BCC at the June 23<sup>rd</sup> meeting.
- Contract executed with Garden Shop Landscaping LLC.
- Construction to being within the next eight weeks (materials ordering taking place).

# **NDF Medusahead Grant**

 Staff from Nevada Division of Forestry, Nevada Department of Agriculture and US Forest Service, State & Private Forestry toured project sites with Washoe County Park Planner, Cheryl Surface on July 14<sup>th</sup>, 2015.

## North Valleys Playground Rehabilitation (south playground)

- \$126,000 (50% Park Tax match) for the North Valleys Regional Park (south playground)
- New rubberized surfacing to improve aesthetics and reduce maintenance costs associated with the existing surfacing and provide safety improvements to existing equipment
- Design is complete and project is currently out to bid.

## On Our Way Grants

- \$53,500 Grant received to complete a signage master plan and produce two logo designs for the SR-28 National Scenic Corridor and the Stateline-to-Stateline –Shared-Use Path.
- \$10,000 Grant received to hire a consulting firm to survey residents living in Washoe County to ascertain their willingness to pay to park for the day and what their preferred price point would be. Contractor hired. SURVEY COMPLETED November 10-12, 2014. Project Completed.

\$42,500 Grant to supplement the SR 431 Mount Rose Scenic Byway Corridor Management Plan.
Technical Advisory Committee and Stakeholder Group have been developed. A public meeting was held
June 3<sup>rd</sup> at South Valleys Library. Public survey available online at:

## Stateline to Stateline Bikeway

- The Tahoe Transportation District and the Federal Highway Administration's Central Federal Lands
  Division have completed the Federal Land Access Program (FLAP) grant Project Agreement approved by
  the WC Board of County Commissioner's November 12<sup>th</sup>. This agreement establishes the partnership
  between the agencies and the federal funding for the Bikeway project.
- Construction for the North Demonstration Project has been delayed until fall 2015.
- The Tahoe Fund has raised nearly 1 million dollars from the community in match for the Stateline Bikeway.
- Operations and Maintenance agreement is going to the BCC for approval August 25, 2015.

## Sun Valley Trail Enhancement Project

- Project received funding from the Recreational Trails Program. Acceptance of grant funds was at the August 11<sup>th</sup>, BCC meeting.
- Project includes OHV trail closures and trail rehabilitation submitted for Sun Valley Regional Park, based on trails plan produced by NV Trail Works.

## Washoe Valley Scenic Byway Corridor Management Plan

- Public Workshop was held at Nevada Division of Forestry Eastlake Fire Station, Tuesday, June 2nd, from 5:30-7:30 pm to solicit public comment on the elements and public desire for the Washoe Valley Scenic Byway.

- Draft plan is being developed for review by Washoe County.

## South Valley Regional Park Master Plan Update

- Wood Rodgers has been hired by the County to update the Master Plan from the previous 2001 plan.
- Public meetings are scheduled for August 31 and September 3, 6-8pm, South Valleys Library
- Project is expected to be completed by November/December of 2015.
