SUBJECT: Update from Smoke Free Parks Joint Agency Working Group and discussion and possible motion on Smoke Free Parks Initiative.

SUMMARY

This item is an update from Smoke Free Parks Joint Agency Working Group regarding the smoke free parks initiative. Two public surveys regarding smoke free parks were recently conducted. The City of Sparks conducted a poll allowing for citizen comments on smoke free parks. Approximately 3,500 emails were sent with a link to Survey Monkey, an anonymous survey tool. The email list included all City of Sparks' employees, Park and Recreation customer database, a subscriber list and those involved in Ignite Sparks during the citywide Comprehensive Plan update in 2016. 289 responses were received, an 8.25% response rate, and 89 comments were received. A complete report of the results is included with this staff report.

On November 20, Truckee Meadows Parks Foundation also conducted a survey about smoking, vaping and use of tobacco products in parks. The survey was conducted through the following platforms:

- TMPF Facebook paid advertisements targeting individuals 18 or older living within 25 miles of Carson City, Sparks and Reno.
- TMPF electronic newsletter
- TMPF's website, Facebook page, Twitter page and Instagram page

The survey closed on November 29 with a total of 984 responses. The full results of the survey along with a complete list of comments are included with this staff report.

BACKGROUND

At the January 18, 2017, concurrent meeting of City of Reno Recreation and Parks Commission, City of Sparks Parks and Recreation Commission and Washoe County Open Space and Regional Parks Commission, a presentation on Smoke Free Parks was given by the Director of Health Policy Research, University Nevada Reno and Washoe

County District Health. During the discussion following the presentation, several members from the respective Park Commissions communicated interest in pursuing a smoke free park initiative.

A Joint Agency Working Group consisting of one Park Commissioner from the City of Sparks, City of Reno and Washoe County was formed to work on this initiative in an effort to be consistent throughout the community. The Joint Agency developed three specific questions to pose to each agency's park commission 1.) Develop a policy or an ordinance; 2.) Prohibit smoking in all areas, or create designated areas; and 3.) Prohibit only smoking/vaping or all tobacco/vape products.

Each of the agency park commissions have discussed these three questions and provided feedback or direction, with Washoe County's Open Space and Park Commission voting to have staff work with the Joint Agency Working Group to draft a smoke and vape free ordinance for all Washoe County Parks.

The Joint Agency Working Group met on November 30, 2017 and each of the agency representatives provided an update. The Joint Agency is scheduled to meet again on December 28, where it will begin drafting the key elements for consistent ordinance language and signage/branding. Staff will work on taking the initiative to their respective City Councils and Commission for direction and possible adoption.

PREVIOUS ACTION

September 5, 2017 Washoe County Open Space and Regional Park Commission voted in support of working with the Joint Agency Working Group to draft a smoke and vape free ordinance for all Washoe County Parks.

On July 13, 2017 Washoe County Open Space and Regional Park Commission appointed Park Commissioner Nenzel to the Joint Agency Working Group for the development of a smoke free park policy.

During the March 7, 2017 Washoe County Open Space and Regional Park Commission voted in support of having staff with the City of Reno and the City of Sparks parks staff on a smoke free park initiative.

RECOMMENDATION

Staff recommends that the Open Space and Regional Park Commission acknowledge receipt of this report on the smoke free parks initiative.

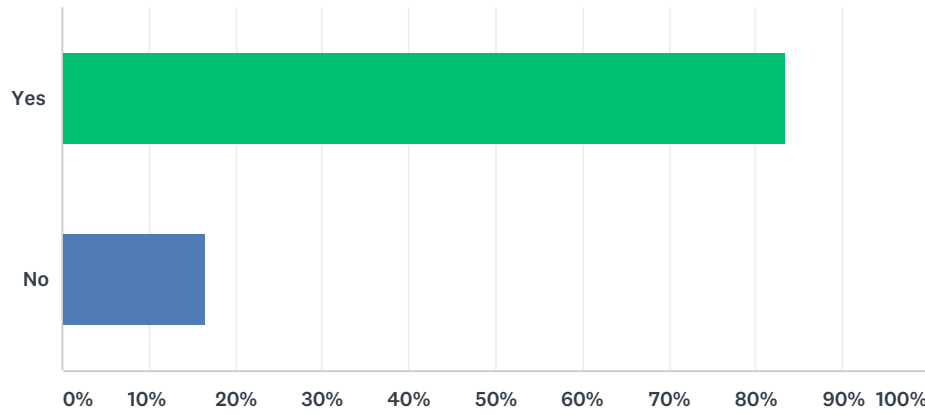

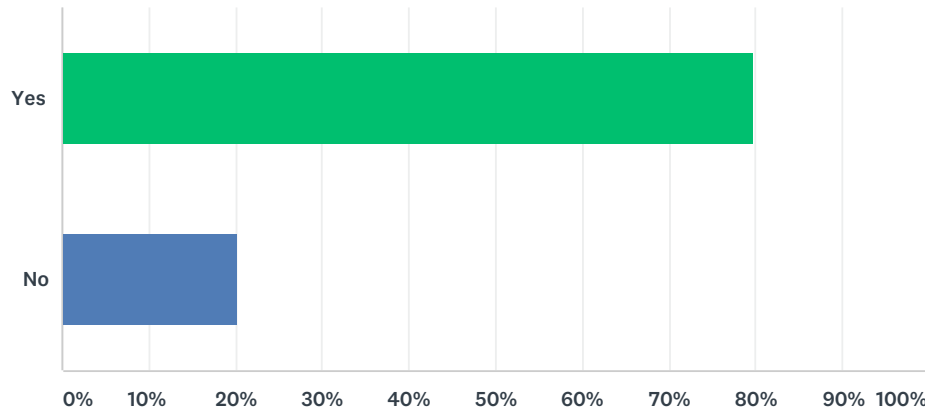

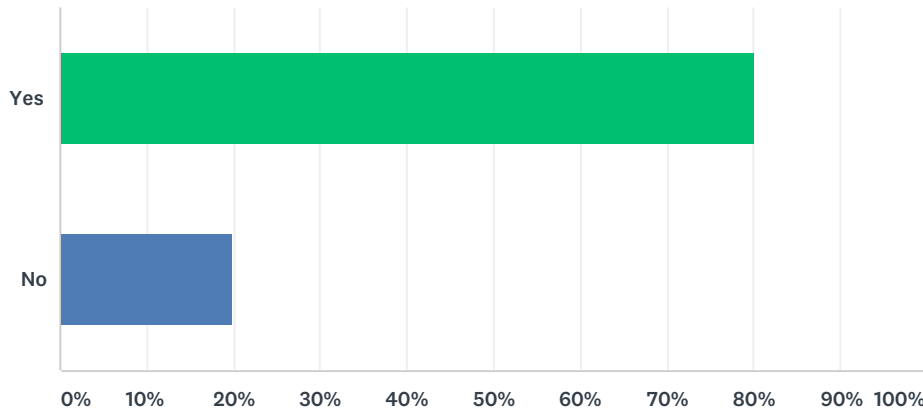

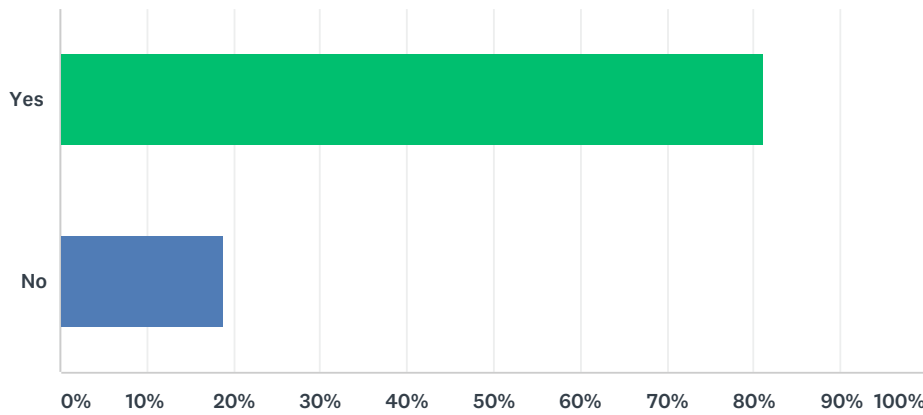

I. Survey Description

On November 20th, Truckee Meadows Parks Foundation sent out a survey to collect public opinion data about rules regarding smoking, vaping, and the use of tobacco products in parks and open spaces. The survey closed on November 29th. The survey was conducted to help inform the Park Commissions of Washoe County, Reno, Sparks, and Carson City, all of whom are considering policy recommendations related to smoking in parks. This survey was conducted solely by Truckee Meadows Parks Foundation and was not commissioned by any local government. Aggregated results found in this report are in the public domain.

II. Data Collection Methods

Truckee Meadows Parks Foundation used Google Forms to create and administer the Smoking in Parks Survey. Electronic communication was primarily used to garner responses. Demographic information, including first and last name, email, and address were collected to ensure non-duplication of responses. Personal information will never be disclosed to any outside organization or agency. These data are solely used to update Truckee Meadows Parks Foundation's records.

The survey was sent out on the following platforms:

1. Truckee Meadows Parks Foundation Facebook paid advertisements
 - a. Advertisements targeted individuals 18 or older living within 25 miles of Carson City, Sparks, and Reno. No further targeting parameters were included.
2. Truckee Meadows Parks Foundation electronic newsletter
3. Truckee Meadows Parks Foundation's website including
 - a. A photo link on the homepage of the website
 - b. A website page linking directly to the survey
4. Truckee Meadows Parks Foundation Facebook page
5. Truckee Meadows Parks Foundation Twitter page
6. Truckee Meadows Parks Foundation Instagram page
7. Partner nonprofits and agencies shared the survey to their own constituents
8. Publicized through local media outlets

III. Survey Results

In total, 984 respondents participated in the survey. Duplicate responses from the same individuals were removed from the survey to ensure the veracity of the results. Survey submissions received from individuals living outside of Nevada were also removed. This reduced the number of legitimate submissions to 963 distinct responses.

The survey indicated a strong majority (76%) of individuals would like some regulation governing smoking in parks, whether it be a total ban or the creation of designated smoking areas. A majority also supported curtailing the use to smokeless tobacco (67%) and vaping (72%) in parks.

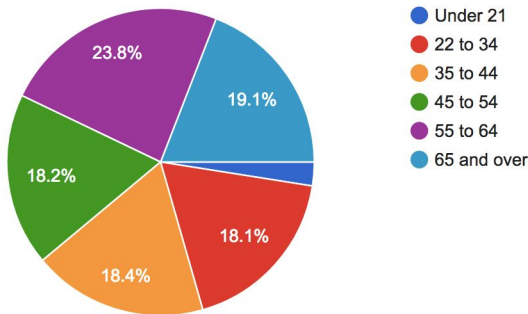


Figure 1. Age breakdown of respondents.

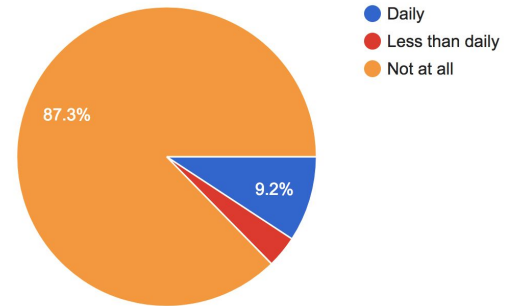


Figure 2. Respondents use of smoking tobacco products.

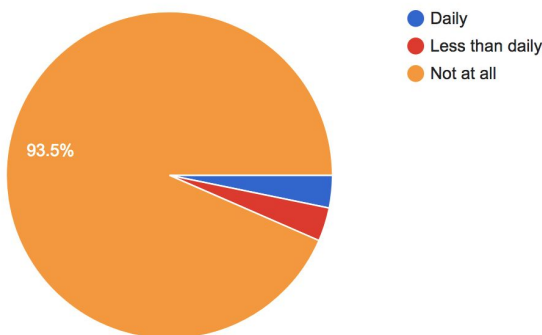


Figure 3. Respondents use of smokeless tobacco products.

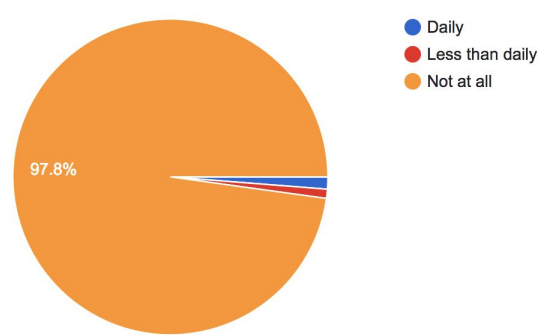


Figure 4. Respondents use of e-cigarettes and/or vaporizers.

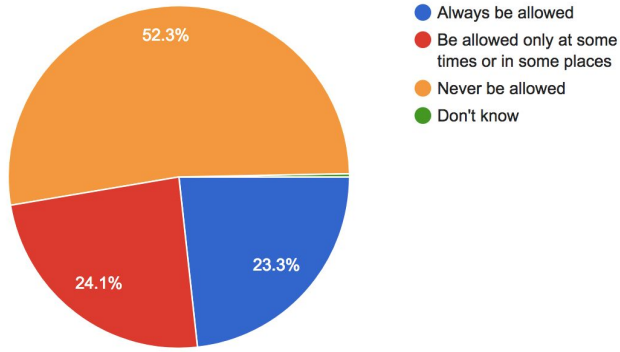


Figure 5. Respondents beliefs regarding smoking tobacco in parks.

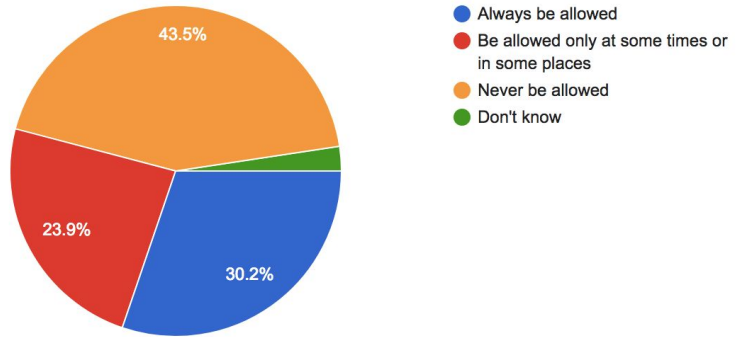


Figure 6. Respondents beliefs regarding smokeless tobacco in parks.

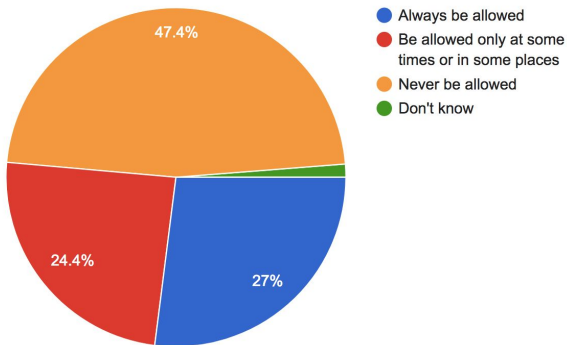


Figure 7. Respondents beliefs regarding e-cigarettes/vaping in parks.

IV. Additional Comments

The final component of the survey was an optional comments section. 443 participants responded. Common themes included a strong concern that:

- any regulation of smoking in parks would be correcting a problem that does not currently exist in the Washoe County, Reno, Sparks, and Carson City parks;
- tobacco products should not be used around children in parks;
- any regulation of smoking in parks would be an infringement on individual rights and would be government overreach;
- any rules or regulations curtailing cigarette use in parks would be unenforceable;
- designated smoking areas should be considered in parks and open spaces;
- cigarette butts are a fire hazard;
- cigarette butts are contributing to the litter problem in parks and open spaces.

The following is the complete list of additional comments. No edits have been made to the comments. Comments are reported in alphabetical order. Please be aware that some responses represent strong opinions and may not be appropriate for sensitive audiences or children.

- A big problem with permitting vaping is that there is no way to tell what substance is being vaped. In Colorado, vaping marijuana is a common way to circumvent public use rules. Nobody should have to risk being unknowingly exposed to secondhand THC when trying to enjoy the public park.
- A park is a place for family and I'd hate to see smokers where my children are playing. In addition, the smoke will add to the air's pollution.
- A person's choice to use tobacco products, whether in the form of cigarettes, smokeless tobacco, or e-cigarettes, is completely individual. A person's choice should not negatively impact the health, safety, and well-being of other individuals, however. The use of tobacco products impacts others around the individual users, and more than the inconvenience and discomfort, their use has negative health impacts on those who choose to abstain from their use. Parks are for the use of the community, and behavior of any kind that makes the community's enjoyment of our parks unpleasant should be disallowed.
- Absolutely no smoking around children. Outside in open spaces should NOT be banned. Smokers: Please be respectful of those who do not smoke. Nevada: please do not become "California Junior."
- After so many clean ups over the last 17 years, the majority of what I pick up has been cigarette butts in the wood chips near play areas and in the tree lines. It's fire hazard as well as gross. I was

surprised how much trash associated with vaping was picked up this fall by me and my kids at various parks.

- After the broken glass, used needles and drug dealers are wiped out of our parks and you have found enough housing for the homeless then you might consider addressing the smoking issue.
- All of these activities are unhealthy for the actors and those around them. Also, users of these products leave their butts and other waste for others to pick up. I know from participating in the Truckee River clean-up where cigarette waste was overwhelming and accounted for most of the debris I picked up.
- All types of smoking should not be allowed. Our young generation needs a safe, healthy, and fresh environment to learn and grow in without the smell of death soaking in their lungs
- Allowing smoking/vaping/smokeless in only some areas would be too hard for already limited staff to enforce. Ban it all together to make it easier for all. Then there is no confusion as to where you can or can't smoke.
- Also smoking Marihuana!
- Although I am not a smoker, I don't have a problem with smoking/vaping in any outdoor arena. As long as the smoke has room to disburse, I'm not opposed. In regards to chewing tobacco, I don't see any need for regulations, other than the chewer needs to contain and dispose of the detritus in an appropriate garbage can. Thanks.
- Although I do not smoke and I think it is terrible for your health and is a huge burden on health care costs, I don't think it is right to not allow people to smoke in public spaces. I have seen park users chastise other park users for smoking, dogs, littering and other infractions and it is ugly to watch. I would not like to create another reason for people to fight in public. I would have written, "Always be allowed" except smoking can be a fire hazard and that is important to remember.
- Although I don't smoke and I hate smoking and the smell of cigarette smoke, I don't believe that the government should heavy-handedly prohibit smoking in an open area. I only have one friend who smokes a pipe and he usually goes off by himself to do so. This country should be about freedom. I also don't think it's possible to prevent folks from smoking in a park anyway. I'm not willing to confront them, as I would in a restaurant, and to call the police seems excessive. Not enforceable.

- As a public space smokers should be able to smoke where ever they want as they pay taxes. Laying this brick down could prevent some one from smoking in public at all. No matter their location
- As long as it's outside. Give them a break...you don't mind using their tax money for your parks
- As long as you aren't on the kids playgrounds it should be okay. It's outdoors
- As much as I hate cigaret smoke, I don't think it is right to enforce a no smoking law in open spaces. That being said, there could be designated smoking areas for folks who smoke. That really isn't going to solve the problem of cancer causing second hand smoke being breathed by someone who dislikes it or who may be on air support.
- As someone who is highly allergic to smoke it's hard enough to survive fire season. Why open it up and possibly risk more fires.

- Aside from the danger and unpleasantness of drifting smoke and its smell, smoking shouldn't be allowed in our parks. Our parks should be full of children and adults pursuing a healthy lifestyle. The less children see or are exposed to smokers the better. Children are observers and naturally want to mimic what they see.
- At least to me, tobacco smoke is one of the most offensive smells there are. As much as I value personal freedom, I feel smoking tobacco should never be allowed where anyone else would have to be exposed to the smoke. Chewing tobacco and vaping are far less noxious alternatives, although those that chew shouldn't just spit anywhere.
- Away from playgrounds and children's activities
- Away from the children's play equipment and park bench and sitting area.

- Can we add no smoking marijuana to the list please. It's hard to take my daughter to a park and then have to leave due to people smoking pot. I don't appreciate having to be exposed to second hand smoke whether tobacco or marijuana.
- Chewing is fine as long as people use a spitter and aren't disgusting about it. Honestly smoking is fine as well if people are responsible for their butts, don't start fires, and don't smoke around other people. Smoking will phase out, no doubt. I don't think we need to spend as much time criminalizing it, but instead focus our efforts on real education. I am a science teacher, and I tell my kids I will smack them if I ever see them smoke. I tell them their grandpa had an excuse; if they do then they're just stupid.

- Children and adults should not be exposed to secondhand smoke from any of these sources in our parks and public places.
- Children are often present in these parks and open spaces. I work for Sierra Nevada Journeys and I have had to lead my group of children away from smokers and teach them in another area. Not only are cigarette butts an unsightly litter problem but there has also been research that shows that they leach chemicals into our streams, rivers, and ground. They contain all the carcinogenic chemicals, pesticides, and nicotine as the cigarette does.
- Children being in parks should not have to be around the smell of smoke, or left over remnants of smokeless tobacco or cigars, cigarettes, etc. due to health and lack of air quality with those substances around children while trying to play in a safe place.
- Children emulate what they see. Be a good example. I also care about my health and my families health.
- Children use these areas and should not have the negative influence.
- Children, elderly and others that should no have to be around smoke, vaping ect go to parks. Smoking should not be aloud because it is a health risk.
- Cig butts left on the ground are disgusting and so are the people who leave them.
- Cigarette butts are as unhygienic and unsightly as dog poop.
- Cigarette smoke is offensive. There are healthier alternatives, such as vaping that don't stink up the air. People are outside to enjoy the fresh air and recreate with their children and dogs. - I am a smoker of many years(not too boastful about it, but that is what I do). I do my very best to smoke away from folks as a respect. I feel it would be VERY unfair to take yet another right from those of us who pay taxes and contribute to society just because we do something to others who may get OFFENDED by because it is something that they don't agree on. We are ALL different, but the one thing we have in common is we all have faults. What is next? I'm afraid to find out!! If there are designated areas, then yes, I agree it should only be allowed there. I am a very courteous smoker, I do it away from others, unless they happen to pass by me. - I am an avid dog walker, and truly dislike the smell of smoking, and hate walking through it!
- I am concerned about fires in our parks. I am of a strong mindset for everyone to have the opportunity to experience our parks and get exercise whether they smoke or not. Due to the fire danger, I would not like to see cigarette's smoked. I do not see smokeless tobacco as a fire danger, I do not know if e-cigarettes/vaping are fire dangers. If not, I think they should be allowed without restriction.
- I am extremely sensitive to smoke and would have to leave the park, smokeless tobacco can be messy, residue is left all over the place.
- I am fine with smoking and e-cigarettes in open areas away from children's play areas as long as butts/trash are cleaned up and cleaning up trash is enforced.
- I am fine with smoking areas, as long as they are away from playgrounds, or other areas where children are around.

- I am thrilled that the regional governments are considering this for our parks and open spaces. Smoking and tobacco use generally leads to litter in our parks, which is bad all around. Also, families and children enjoying the outdoors shouldn't be exposed to secondhand smoke.
- I believe it should not be limited to tobacco but to include all forms of smoking of pot.
- I believe it's up to the person, if they want to smoke or not smoke. Personally it doesn't bother me.
- I believe people shouldn't be exposed to toxicity from tobacco 2nd and third hand smoke as well as animals be exposed to the toxic butt discards from smokers that do not dispose of their wastes responsibly.
- I believe second hand smoke from both cigarettes, CIGARS, and vape pose a health risk to many people. There should be designated smoking areas so those who are affected can avoid exposure.
- I believe that there should be some areas where tobacco users can be accommodated. Those areas should be maintained and cleaned on a regular basis.
- I believe there should be designated smoking areas so that people who do not smoke are not exposed to those who are smoking in public. It is often difficult to find a place where the air is not full of cigarette & vape smoke. It is disgusting! I also believe that smoking in parks & open spaces should only be permitted when it is safe and NOT in dry fire-prone areas.

- I do not see the need to ban smoking in an outdoor area. While I don't smoke I feel this is going a bit too far and is somewhat ridiculous. However, I am very disgusted with how disrespectful smokers are in leaving cigarette butts all over the ground and especially in play ground areas for someone else to clean up.
- I do not smoke or use tobacco products at all nor do I use e-cigarettes or vape. However I don't think it's up to me or others to not do these things. - I don't think there is any smell or debris from e-cigarettes/vaping. If I'm wrong, then they should only be allowed in designated areas also.
- I don't think you should eliminate smoking entirely, but to avoid having someone smoking next to me in a park, I think there should be designated areas for smokers.
- I don't want to be exposed to it, or it's waste. I don't want to walk by it or be in the area of it. And too many people are inconsiderate about their use around others. If you can identify specific areas for its use that or not in main walk areas, then I can understand this option. I also feel that electronic cigarettes can be much less offensive and less unhealthy to non smokers, and that fact should be taken into account.
- I help clean Woodtrail Park and it is so disgusting to have to pick up cigarette butts that are all over. It is as bad as cleaning up after all the dogs.
- I just really dislike the smoke in the air.
- I love the trees and open spaces and getting away from people. I don't care for the smell of cig smoke which takes away from the beauty of the outdoors. I'm not after taking away rights from smokers as they can destroy their bodies as they see fit, but I object to them taking away my right to a beautiful experience and impacting my health. It's bad enough their bodies and clothes reek of cig smoke smell.
- i moved here from california to escape all their over regulated state. please don't start the same crap up here
- I often run and exercise outdoors in the community parks and smoking makes it an unpleasant experience.
- I often smell cigarette and other smoke when I use the park. It is also annoying that tobacco users throw their butts and wrappers on the ground.
- I pick up cigarette butts in the dry grass next to old dry wooden fences a lot in my neighborhood park - and am afraid for a fire and it is filthy to have cigarette butts in the grass
- I prefer not having these products around however maybe a reasonable policy would be appropriate for those who do.
- I really believe we have other more pressing issues about which to issue and enforce regulations. Tobacco use in parks presents little problem to other visitors because parks, being open-air, allow for quick smoke dispersal and thus really small exposure to others and also allow one to easily move away from the smoker or vaper. I would rather see enforcement personnel engaged in real problems such as loud noises, illegal ATV or OHV usage, illegal firearms usage, dumping, and illegal fires.

- i SMOKED FOR 40 YEARS....SO I GET IT....PEOPLE ARE ADDICTED. BUT IT IS SIMPLY THE NASTIEST HABIT IN THE WORLD.....AND BESIDES THAT, IT IS GOING TO KILL YOU. I DON'T MIND IF YOU SMOKE. I JUST DON'T WANT TO HAVE TO DO IT WITH YOU. I ACTUALLY WENT BACK AND CHANGED MY ANSWERS FROM "SOME TIMES AND SOME PLACES TO "NEVER". IT JUST NEEDS TO STOP..... COMPLETELY.
- I strongly support banning all smoking in parks and open space for the following reasons: think of all the forest fires started by irresponsible people and smoking, when I am out walking in a park or on Peavine, I shouldn't need to smell someone's smoke.
- I take care of the Parks for Storey County. I've been doing it for 37 years. My only complaint is the parks being used as ashtray. It's unbelievable how many cigarette butts I pick up on a daily basis. If people would take care of their butts I'd have no problem with them smoking in a park.
- I there is a public function smoking should not be allowed where the crowds are, i.e., carnivals, etc. There should be designated areas, downwind, if possible. Smoke and its smell travels really far and can be annoying.
- I think designated smoking areas are the best way to keep parks safe from accidental fires, as well as provide an area for those who smoke/vape to feel welcome at the parks. We don't want to alienate people from using the parks!
- I think exposing people who do not smoke to second hand smoke is wrong!
- I think it is important to consider the safety of the parks and the participants, as well as the influence that smoking may have on children playing at the park, however, it is an outdoor space so if it in an area that has proper disposal receptacles and some distance away from playing children (to provide clean air and proper adult influence) then I think it would be a good compromise.

- I think it is justified to post "no-smoking" signs near park equipment (play structures and ball courts) but to say no smoking in this big open outdoor space is really putting too much restriction on the issue. Smokers cannot smoke inside most public places, probably just in their homes, cars, casinos, and to tell them they can't go sit on a park bench to smoke would have a lot of back lash. I personally avoid all tobacco products and don't want my kids around it either, but if they are using ash trays and trash cans, I don't see why they couldn't smoke in the park away from children. I don't really see anyone following a rule like that, either, without any constant enforcement. Maybe no smoking during events at parks that have groups of people gathered and/or food vending.

Restrictions on where and when anyone who wishes to indulge can do so are appropriate under the circumstances, with precautions in place to minimize exposure to the environment and other people in it.

- I'm definately against smoking in public spaces... i have asthma and breathing in cigarette smoke really bothers it.... now im not sure about the e-cigs and vapes.. if there is not a public health risk maybe they are ok.... dont know enough about them.... also am concerned that there would not b funds or staff to enforce a no smoking ban
- I'm not around people who smoke and don't want to be around it in public.
- I'm disappointed I have to provide personal information for your survey. The only problem I have with tobacco products used in parks is the smokeless (chew). I don't like the spit that goes along with it but this would be no different if tobacco was not involved. Smoking cigarettes, cigars, vaping, etc is not discouraging me from taking my kids to the parks. The crime, broken bottles, used condoms, etc (which are already banned) do prevent me from visiting.
- If a smoker wants to smoke in a private space that's fine. When they smoke in a public space and it affects my health and enjoyment that is not ok.
- If all smoking is banned, it will help curb the marijuana smokers also. Since it was made legal, smoking of it in parks has greatly increased!
- If at a park that has a large crowd (such as Rollin' On the River) smokers should have the courtesy to move out of the crowd to an area less congested. Therefore, to keep matters simplified, designate an area away from the crowd, but still in the park.
- If children are present smoking should not be allowed.

Vaping, while not necessarily as harmful to
