**New Zealand Mudsnail discovered:** A new, non-native aquatic invader, New Zealand mudsnail, was discovered on a boat at an off-ramp inspection station in Meyers on May 25. It has also been detected in the Owens River Valley, the Cosumnes River Valley and other wetland locations throughout the California Central Valley. The mudsnails, which prefer streams, rivers and creeks, are typically transferred from water body to water body via non-motorized boats like canoes, kayaks and other assorted paddle operated watercraft. **2010-11 Budget Approved:** County Commissioners approved a general fund budget of nearly \$308 million which reflects almost a 10% reduction from the 2009-10 budget. With this new budget, Washoe County has reduced spending by \$123 million and eliminated about 600 positions in the last four years in response to declining sales tax and property tax revenues which comprise about 75% of the total general fund. The general fund is about 45% of the County's total budget of nearly \$700 million.

**Voluntary Labor Cost Concessions:** County Commissioners, Elected Officials, County Manager, senior management and division heads have all taken voluntary labor cost concessions equivalent to a 3.7% salary reduction plus contributing \$25 per pay period toward their health care costs to help meet the \$25 million budget deficit projected in the 2010-11 budget. Negotiations are current underway with the County's employee associations regarding concessions for represented employees. Employees have taken wage reductions and eliminated scheduled cost of living raises in the past couple years.

Primary Election Results Canvassed: Washoe County Commissions officially “canvassed” (approved) the 2010 Primary Election results on June 15, 2010. The 2010 Primary Election Highlights:

- Voter Turnout: 33.7% (72,194 voters out of 214,164 registered to vote)—highest primary election voter turnout in 12 years
- Early Voters: 26,246 (36.3% of turnout)
- Election Day Voters: 39,542 (54.8% of turnout)
- Absentee Ballot Voters: 6,406 (8.9% of turnout); 82% of all absentee ballots requested were returned (7,841 absentee ballots requested)
- Party Turnout: Democrats 29.3% (24,861 voted out of 84,734 registered); Republicans 49.5% (41,780 out of 84,444); Nonpartisans 12.3% (5,553 out of 44,986)
- 14 Early Voting Locations (5 public, 9 private commercial)
- 94 Election Day Polling Places
- 805 Edge Touch Screen Voting Machines Used for Election Day and Early Voting
- 559 total Poll Workers for Election Day and Early Voting (60 were county employees who served as polling managers and asst. managers)

I-580 Interchange During High Winds: Eastlake Blvd is a secondary truck route which means when both 395 and 429 (Bowers Rd) cannot be used because of high winds, oversized vehicle, construction or some other restriction, trucks will be directed down Eastlake Blvd. Construction at the interchange of the new I- 580 with the existing US 395 and SR 429 will begin this summer with completion in approximately one year. Nevada Department of Transportation (NDOT) will be directing truck traffic from US 395 onto SR 429 during wind events.

Solar Photovoltaic Panels Installed: Washoe County has begun installing solar photovoltaic panels at the 9th and Wells County Administration Complex. The installation at the Complex is one of three solar photovoltaic projects currently underway at County facilities. The other two projects are located at the Northwest Library and Washoe County Senior Center. Funding for the entire \$722,460 project comes from a \$401,200 Department of Energy Efficiency and Conservation Block Grant and \$600,000 in NV Energy SolarGenerations Rebates Program reimbursements. Beginning on June 4, 2010, the Charles M. McGee Center, located at 2097 Longley Lane, Reno will cease its overnight operation of youth residential services. The suspension is the direct result of departmental reductions needed to meet the County’s budget shortfall. The McGee Center will continue daytime operations Monday through Friday from 8am to 5pm. Services will include the reception, processing and case management. For youth who may

require overnight residential placement, Juvenile Services is currently negotiating respite care contracts with community providers. The McGee Center will also offer on-site services through a Day Program for female youth. Services will include a Washoe County School District site and afternoon programming through a referral and screening process. These efforts are in alignment with the County's goals of maintaining service levels, maximizing employment and achieving sustainable labor costs. New Fire Station Grant Accepted: County Commissioners accepted a \$2.5 million FEMA grant to build a new fire station to serve the Arrowcreek area. In the short-term, the existing Bowers fire station 4-person crew will be split into a 2-person crew for both the Bowers and Arrowcreek stations with seasonal fire crew stationed at Bowers during wildland fire season. Commissioners directed the Fire Chief to work with staff to develop a long-term staffing and funding proposal for the new station. Construction could begin within a year with a possible completion date of June 2011.

Sewer and Water Utility Financial Assistance Program (Assembly Bill 54): In 2009, Washoe County sponsored Assembly Bill (AB) 54 to authorize the County to establish a mechanism to provide financial assistance to help owners of a private on-site well and/or septic system convert over to a community water or sewer system. The legislation does not force private well and/or septic owners to convert over to a community water or sewer system

Regional Water Commission Act: This act was passed by the Nevada State Legislature in 2009 and requires that Truckee Meadows water management agencies to evaluate the possibility of consolidating public water providers in Washoe County and include the results of this evaluation in the 2011 update of the Regional Water Management Plan to the State Legislature. On December 10, 2009, the Truckee Meadows Water Authority (TMWA) and the Board of County Commissioners (BCC) met in a third joint meeting and unanimously approved the Interlocal Agreement (ILA). The ILA will govern and provide a framework for the merger process and allow the entities to develop and implement a plan to provide the most efficient operation of the combined water systems. A final closing date has not been determined and will depend on when market conditions are right for debt restructuring. With the ILA providing the framework for the merger process, the transition will continue through most of 2010, addressing due diligence and risk allocation issues. The Sheriff's Office reminds citizens that drugs and/or alcohol usage plays a major factor in violent crime during graduation time. Detectives see that juveniles, both male and female, are using alcohol, illegal and prescription drugs at younger age, which increase the likelihood of placing themselves in dangerous situations. Alcohol is the foremost contributing factor in sexual assault cases being investigated by the Detective Division from May to July. The Sheriff's Office recommends under-aged persons celebrate graduation in an alcohol/drug free environment, stay close to people you trust, don't accept food or drinks in opened containers offered by unknown people, and avoid high-risk situations. The Sheriff's Office encourages victims and witnesses to report violent crimes immediately. Call 911 in case of an emergency, for non-emergencies call 334-COPS or Secret Witness at 322-4900.

Starting in June, 2010, Reno City Council meetings will convene at Noon. Public comment will continue to be heard at Noon, and will now be the first substantive item on the City Council agenda. Public hearings will commence no sooner than 12:15 pm and controversial public hearings that draw more public participation will continue to be held at 6:00 pm. The regular public meetings will still be held in the Council Chambers, or other properly noticed location. They will still convene on the second and fourth Wednesday of the month except for July, November, and December when the Council shall meet on the first and third Wednesday of the month and the month of August when the Council shall meet on the third and fourth Wednesday of the month. The new schedule will create staffing efficiencies permitting cost savings, while continuing to encourage public participation in City Council meetings. Due to budget constraints, the Justices of the Peace at Reno Justice Court have authorized the Court Administrator to close the filing office doors to the general public one hour early on Monday, Tuesday, Thursday and Friday. This one hour of uninterrupted desk time will provide a reduced court staff the opportunity to accomplish their daily work assignments and complete other backlogged duties without incurring overtime pay or compensatory time. Effective July 1, 2010, Reno Justice Court's new hours of public operation will be: Monday, Tuesday, Thursday and Friday from 8am to 4pm and Wednesday from 7:30am to 5pm. All court cases in process between the hours of 4 - 5pm on Monday, Tuesday, Thursday and Friday will proceed and all defendants involved in those cases will have the ability to register for various programs and/or pay or establish payment plans for imposed fines and fees. Beginning July 2, 2010, the Reno Municipal Court will be changing its court operation hours. Changing the hours of operation will provide budgetary savings for the Court. The Court's hours of operation will be 7:30 a.m. to 5pm, Monday through Thursday, and 7:30 a.m. to Noon on Friday. The Reno Municipal Court was successful in reducing its projected budget for the upcoming fiscal year by 21% through employee compensation reductions and a

reduction in spending. Salaries were reduced by 5% rather than losing employees through a reduction in force. A 38-hour work will be instituted for employees as well. All Reno Municipal Court staff, from entry level positions to the judiciary, participated in this plan, without exception. Visitors to the court will notice the information desk at the entrance to the Reno Municipal Court has been removed. For those conducting business at the court please check in at Window 1 of the Clerk's office. Please remember to verify the court listed on citations or paperwork to help save time by not waiting in line for the wrong court. Individuals will still be able to make drop payments (check/money order only) for the Reno Municipal Court in the drop-box on the Court Street side of the Mills B. Lane Justice Center building.
